Report from the Chair

It has been another remarkable year for The Duke of Edinburgh's International Award – Australia. The increasingly recognised importance of accredited non-formal education and learning amongst employers and tertiary education providers has helped drive further demand for The Duke of Ed Framework across existing and new Duke of Ed Centres.

This year we celebrated another record, with 32,940 new registered users of The Duke of Ed Framework, noting that this is the first year we welcomed Gen Alpha registrations. It is a strong indication that The Duke of Ed remains relevant, modern, and critical in promoting and accrediting individual achievement and personal development. Our proof extends beyond the number of new registrations – the number of young people completing a Duke of Ed Level and continuing on to start the next Level are on the rise. 2024 also welcomed a record number of Duke of Ed Employer and Duke 4Sport partners.

The Critical Role of Non-Formal Education.

As many of us involved with The Duke of Ed are aware, we operate in a field that is vital to developing critical life skills while nurturing wellbeing.

Non-formal education:

- Serves to complement formal education in an individual's lifelong learning journey;
- assumes that education can occur beyond spaces limited by traditional classrooms;
- addresses the needs of people of all ages without necessarily adhering to a continuous structure or pathway; and
- plays a significant role in helping marginalised populations overcome or mitigate disadvantaged social conditions.

The Duke of Ed Australia continues to work with an increasing number of high schools and youth member organisations Australiawide, as it makes a critical contribution towards ensuring the universal right of all individual young people to a holistic education. Our commitment to this was further echoed by HRH The Duke of Edinburgh KG KT GCVO, Chairman of The Duke of Edinburgh's International Award Foundation, during his visit last November.

Our Award Ambassadors, State and Territory Award Committees and their teams deserve special recognition for their outstanding dedication to our Duke of Ed community. Their efforts empower young people with a respectful and supportive pathway to enable their self-learning.

To our young people, their families, Duke of Ed Leaders, and volunteers - congratulations on embarking on a life-changing experience that really delivers. It will become a guiding force influencing your future in profound ways, and we hope will be a part of the foundations for your future success and happiness.

As always, and as an internationally respected education provider, young people are at the heart of everything we do. We continue to advocate for a positive future for all young Australians; ensuring they are ready to succeed in their further study and employment and; make meaningful contributions to their communities.

My first year as Chair has been both busy and rewarding. Our organisation is always searching for the best possible ways to engage with young people. 

More Modern, More Discoverable, More Visitation

This year we launched a refreshed website, adopting a more modern brand direction, messaging, easier access to resources, and vastly improved navigation. This is phase 1 with further developments in the pipeline to enhance Duke of Ed Leader experience and accessibility to resources; and further building on the enhanced functionality of the overall site to better serve all our key audience groups.

The important visit, in November 2023, by HRH The Duke of Edinburgh KG KT GCVO demonstrated our global commitment to continue to evolve and adapt to the demands of modern society and the critical needs of young people. The visit achieved national media coverage shining a positive light on The Duke of Edinburgh's International Award, its positive impact on young Australians; and sparked important conversations among the education, employment, and emergency services sectors around how The Duke of Ed Framework is a solution to nonformal education demands and voluntary needs. Major Handbook Review

In April 2024, the NAO undertook a major review of the Handbook, a key document that covers the principles and procedures to complete a Duke of Ed Level. The revised Handbook adopts the new brand language, glossary, and messaging to deliver a modern, fit-for-purpose document to make it easier for readers to interact with the content.

Strengthening Partnerships Driving Reach

Over the past year, The Duke of Ed has strengthened its collaborations with over 230 diverse organisations nationwide, including businesses, sports groups, and tertiary education institutions. Through these key partnerships, we remain dedicated to advancing The Duke of Ed's mission of empowering young people. These alliances provide crucial benefits such as paving the way for employment opportunities, enhancing access to higher education, and nurturing the development of essential life skills.

Increasing Access

We continue to make The Duke of Ed Framework more widely available and accessible, increasing the number of young people using the Framework from diverse backgrounds. In FY22/23 the Specialised Award Centre funding program was launched to provide increased support for Duke of Ed Centres working with young people experiencing severe disadvantage.

Financial Summary

Consolidated Statement of Financial Position

Consolidated net assets as at 30 June 2024 were \$6,354,853. The Directors consider that the Group is in a robust financial position to manage present commitments.

Consolidated Pre-Audited Financial Results

The Duke of Edinburgh's International Award – Australia recorded a loss of \$45,106 for FY24 compared to a loss of \$2,719 in the previous financial year. This follows significant investment in development projects.

The Friends of the Award recorded a surplus of \$763,555 for the year compared to \$12,780 in the previous financial year. The consolidated surplus for the year was \$718,449.
