

THE DUKE OF EDINBURGH'S INTERNATIONAL AWARD – AUSTRALIA NATIONAL INSURANCE REQUIREMENTS AWARD CENTRES

This includes insurance coverage for Participants and Volunteers (Paid & Unpaid)

Each Award Centre must keep current at all times during their licence the following insurance policies for the benefit of all Award Program Participants and Volunteers (as a minimum):

Public & Product Liability insurance

1. Public & Product Liability insurance with a minimum cover of \$20,000,000 (\$20 million) for any one incident or series of incidents arising from one event for public liability and in the aggregate for the year in respect to product liability.

a. Public & Products Limits of Liability:

b. Public Liability \$20,000,000 any one occurrence

c. Products Liability \$20,000,000 any one occurrence and in the aggregate

d. Errors & Omissions \$5,000,000 any one claim and in the aggregate

Personal Accident insurance

3. Personal Accident insurance covering all Participants and Volunteers (paid or unpaid) in relation to Award Program activities, for a minimum aggregate limit of \$3,000,000 and Death & Capital Benefits limit of:

Insured Persons:

Voluntary Workers:

- a. Category A All Participants of the Insured's programs aged 18 years and over
- b. Category B All Participants of the Insured's programs under the age of 18
- c. Category C All Voluntary Workers of the Insured

Limits of Liability:

- a. Aggregate Limits \$3,000,000
- b. Death & Capital Benefits \$150,000 (For Category A&C)
- c. Death & Capital Benefits \$100,000 (Category B)

- d. Category A All Staff Members
- e. Limits of Liability:

- g. Death & Capital Benefits \$150,000 (For Category A)
